**FIRST AID:**

**Inhalation:** Remove affected person to fresh air; If breathing is difficult, supply oxygen. If breathing has stopped, begin artificial respiration.

**Skin:** Remove contaminated clothing while flushing affected area with water for 5 minutes. Launder contaminated clothing before reuse; seek medical attention if irritation develops and persists.

**Eyes:** Check for and remove contact lenses. Immediately flush eyes for 5 minutes in clear running water while holding eyelids open; seek immediate medical attention if irritation persists.

**Ingestion:** Induce vomiting as directed by medical personnel. Never give anything by mouth to an unconscious person. Seek medical attention.
