## Directions:

- Dilutions will vary from full strength to 1 oz. per gal (1 to 128) depending on soil accumulation and the nature of the surface.
- This product is to be used in conjunction with the STEP TWO CLEANER for roof cleaning applications.
- Released soil should be removed by rinsing with clean water or wiping with a clean cloth or sponge.
- Suggested dilutions are for average soil loads — use less water or soak longer for heavily soiled surfaces.
- Soak down and cover all foliage before using product and re-soak all foliage when finished cleaning.

## ROOFS:

- Dilute Activator 1:1 with water and agitate before use.
- Add the Step Two Roof Cleaner before cleaning roofs.

Also can be used as a general cleaner for any exterior surfaces. Roof Activator will remove mildew, stains and grime from walls, decks, concrete, fences, printing presses, spray rigs, mining equipment and more...
