**Directions:**

- **Kitchen Cleaning:** For difficult cleaning jobs use dilution 1:5 for oven cleaning, deep fat fryers and greasy floors. For walls, light fixtures, refrigerators, etc., use dilution 1:10 to 1:20 and wipe clean.
- **Automatic Scrubbing Machine:** For light duty cleaning use dilution 1:50 for regular floors. For heavy duty cleaning use dilution 1:25. To strip wax off floors, add 1 cup of ammonia to each gallon of solution. Allow solution to remain on floor for 10 minutes. Agitate with floor scrubber, and then rinse well with clear water.
- **Floors and Walls:** Use dilution 1:50 or 2 ounces per gallon. Wipe and rinse clean.
- **Machinery and Equipment:** Use dilution 1:25 or 5 ounces per gallon. Soak for 5 to 10 minutes and then rinse with clear water.
- **Heavy Duty Degreasing:** Use dilution 1:3 and spray on. Allow to soak for 5 to 10 minutes and then pressure rinse with clear water.

KEEP OUT OF REACH OF CHILDREN.
