Directions:

- This heavy duty non-butyl cleaner can be used on any surface not damaged by water. Can be used for both manual and pressure washing equipment. For all food contact surfaces be sure to rinse well with potable water.

- **Light Duty Cleaning:** Use 2 oz. per gallon water for walls, Painted Surfaces, Tables, Chairs, Waxed Floors, Stainless Steel Surfaces, Formica, Restrooms, etc.

- **Medium Duty Cleaning:** Use 4 oz. per gallon water for Hoods, Grease Filters, Refrigerators, Freezers, Quarry Tile, Food Trucks, Lighting Fixtures, Air Conditioning Coils, etc.

- **Heavy Duty Cleaning:** Use 10 oz. per gallon water for Cutting Tables, Band Saws, White Sidewalls, Automotive Engines, Printing Presses, Mill Machines, Fork Trucks, etc. Rinse with water.

- **Extra Heavy Duty Cleaning:** Use product full strength for Grills, Ovens, Deep Fryers, Greasy machinery, Diesel Engines, etc. Rinse with water.
